

FACTS**WHAT DOES BMW SOUTH COUNTY DO WITH YOUR PERSONAL INFORMATION?**

Why? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What? The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- account balances and payment history
- credit history and employment information

When you are *no longer* our customer, we continue to share your information as described in this notice.

How? All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons BMW South County chooses to share; and whether you can limit this sharing.

For our everyday business purposes —such as to process your transactions, maintain your account(s), respond to court orders and legal investigations, or report to credit bureaus	Yes	No

For our affiliates' everyday business purposes —Information about your transactions and experiences	No	We don't share

How does BMW South County protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does BMW South County collect my personal information? Why can't I limit all sharing? Definitions

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <input checked="" type="checkbox"/> <i>BMW South County does not share with our affiliates</i>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <input checked="" type="checkbox"/> <i>BMW South County Kia does not share with nonaffiliates so they can market to you.</i>
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <input checked="" type="checkbox"/> <i>BMW South County doesn't jointly market</i>
